THE EMPHASIS IS ON THE TRANSFERENCE OF SKILLS TO THE LOCAL PEOPLE AND THUS THE CREATION OF OPPORTUNITY - SEEN AS MORE OF A PERMANENT SOLUTION RATHER THAN JUST THE PLACEMENT OF RESOURCES INTO IMPOVERISHED REGIONS. CONCERN AMERICA'S FIELD PERSONNEL LIVE IN THE COMMUNITIES WHERE THEY WORK, SERVING FOR AT LEAST TWO YEARS FOR A MINIMAL STIPEND. THE COUNTRIES IN WHICH CONCERN AMERICA CURRENTLY WORKS ARE MEXICO, GUATEMALA, COLOMBIA AND MOZAMBIQUE.

THE CRAFT PROGRAM SERVES SEVERAL FUNCTIONS. IT PROVIDES DIRECT ASSISTANCE TO FAMILIES IN SUCH WAYS AS DEPENDABLE MARKETS AND FAIR PRICES WHICH REINFORCE SELF RELIANCE AND INITIATIVE.
